### D18 Remote Communities and Special Needs June 2014 Report

Remote Communities Special Needs recently meet with two of Minneapolis Councilman Abdi Warsame's staff and did an Alcoholics Anonymous informational presentation. We also left Intergroup cards, an Area 36 contact card and some pamphlets.

Last week we purchased literature for two libraries that serve our District. There was a few learning opportunities as we didn't expect Hennepin County libraries to decline some AA literature they currently do not have. HCL asked that we do not donate any Braille or foreign language literature at this time. Through this we learned that the MN Braille & Talking Book Library services all of Minnesota. After reaching out to them they requested we only donate one copy of the two AA Braille titles currently not in their possession.

Based on the library feedback here is what we have purchased.

For MBTBL

1- M-35 12 Steps & Traditions/ Braille

1- M-50 Daily Reflections / Braille

For HCL

3- B-16 Large print softcover

3- B-19 Daily Reflections / large print

3- DV-11 DVD Closed Captioned BB in ASL (not all stories)3- DV-12 12 Steps and Traditions CC DVD in ASL for deaf/ hearing impaired

The total cost was \$119.75 instead of the \$164 approved at the May District meeting.

The District 7 Remote Communities chair expressed a desire to be involved in our literature purchase and has been given approval to contribute half of the funds needed so the total cost to District 18 will be \$59.88.


