

Concept VII

### Long Form:

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

### Short Form:

Concept VII - The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.

[The A.A. Service Manual/Twelve, Concepts for World Service (BM-31)]

My interpretation is as follows - the next few sentences re-state Concept VII in different ways:

- 1. This means the Trustees manage all of the world service affairs, but if the delegates (who make up the Conference) disagree they pull rank. The power of the Conference will nearly always be superior to the legal power of the Trustees.
- The Trustees hold the Conference accountable by the law, and the Conference holds the Trustees accountable by Tradition. The Trustees are trusted servants. Tradition Two states, "Our leaders are but trusted servants; they do not govern."
- It's like the president of the United States' power to veto congress. 99% percent of the time, the President does not use veto power because congressional legislation largely meets the president's approval.

Therefore, if the Trustees keep in mind that the Conference is the real seat of service authority, we may be sure that neither will be seriously tempted to make a "rubber stamp" out of the other. We may expect that in this way grave issues will continue to be resolved, and harmonious cooperation will be the general rule. - Malcolm F.


