Jason (Alt-Chair). Thank you to Lindsey for all the stellar work to get postcards designed and printed. Committee will meet next Wed 7pm? at Caribou Coffee on New Brighton. We will now need volunteers to make phone calls. Human resources, cops, clergy, lawyers, healthcare professionals... **Get ahold of some of these cards and get these to the professionals in your lives!!!** We will have a stack of these at next district meeting so that these can get out to meetings.

We are creating database so that we can continue where we left off next time we do this (every two years) so that can continue the learning/info forward. It will be on google drive.

11. <u>New Business</u> (8:00)

a) Committee Financing Requests (none received as of Monday 9/8/14) none.

b) **D18 Budget Discussion** (10 mins)

DCM: Your job next month will be to vote on 2015District budget.

Treasurer: Please send/call me with your questions!

We have distributed two budget options as a place to begin our discussion:

The "All desires budget" (side 1) has a deficit of -3670.00; we don't think this is a good, prudent idea; It isn't prudent as our traditions ask us to be. Seems to me that we should not budget or spend above what the groups are funding us to do. The budget request from the Archivist (\$2671), to fund that position, is quite high, and accounts for a good amount of the deficit.

We left the amount for **committee expenses** (combined = **\$1995**) the same on this budget. Travel (\$3400 total for DCM/alt/officers/committee chairs): We had a lot of local events this year, which kept travel expenses down. However, WC Regional meeting is in Nebraska and Regional Forum is in Wyoming, so the cost will be greater in 2015. Our guidelines say that we are to fund the WC Regional and the Forum, as well as RUSC (Rec, Unity, Service Conf).

Committee Chair Question: Is there any explanation of the Archivist's budget? Do we know why it is so high? DCM: This is the budget he submitted for what he considers important for the archivist to fulfill the responsibilities of his position. Treasurer: It is all for mileage reimbursement; it does not include a request for any other travel related expenses (no hotels, etc). It is all travel to committee events, RUSC, or the Area Repository. Mileage is based on the approved cost (about 35 cents/mile).

Question: Doesn't area have own archivist that brings archives material to the same places? DCM: Yes.

"Prudent Budget" is on Second Page. This is DCM's suggested budget based on past 3 year averages for both revenue and spending, and also cutting some things a bit.

This reflects: \$1795 for all committee expenses combined, \$200 for archivist, \$2200 for travel. We cut the travel budget down significantly by having only the DCM go to WC Regional and the Alt-DCM only goes to the Forum, instead of both officers going to both events. Whomever goes to the event will make detailed notes and report back to the other officer and District as a whole.

Additional Discussion about specific scenarios about spending/deficits/overspending.

Area 36 Budget Discussion (10 mins)

Area budget will be voted on, as well as election of officers at October Assembly.

DCM: Area has presented a budget with an \$1100 deficit. Uncomfortable with a budget that isn't prudent. 41% committee expenses at Area, while our district is only about 5%? Is it possible to cut some items, such as a fold-over letter instead of an envelope-stuffed letter for the Finance Letter? Cut some travel for some committees? Do we need to participate in all of the events? Discussion of specific questions about specific budget items followed.

Question: What are the archives? Is it a museum?

DCM/Treasurer: It is our history! There is a proper archive appropriate storage repository facility where there are many boxes filled with photos and other kinds of things. The Glenco Archives facility is less expensive than the last one was; 60 miles roundtrip to archives from Mpls.
