There has been a disconnect between GSO and the groups for some time. It's hard to keep our group contact information up to date and accurate. I believe that a lot of this disconnect starts with us at the local level. We are the ones that can start to fix this. Only groups with accurate contacts can be kept in the loop. Apathy in AA: people do projects, but don't know what other people are doing. This study points out the communication problems, both internal and external. Also, that the GSO might be doing our 12th Step Work for us.

AAWS is our publishing arm, and if we aren't supporting them through book sales. then book publishing will suffer. Self Support for GSO: it begins with me. Birthday Plan!! If your district is flush, then maybe send your district birthday money to GSO. How do know what to spend our money on if the groups aren't participating and letting us know what they want/need? How does GSO know what we want/need if communication is suffering? Delegates at GSC will be brainstorming ideas in response to this study. As we discuss this, ideas will come forward. Some may be big, like moving GSO location, or GSC locations. We are not in panic mode, but need to be aware and looking to the future.

Proposal is for GSO to figure out which links they want to promote, and promote more digital sales by giving a tool to groups to display at their meetings.
